Report on Race Meeting held at Morphettville Parks Racecourse  
by the South Australian Jockey Club on Saturday, 20 July 2019

**TRACK:** Soft 6 (Moist but not a badly affected track)

**RAIL:** Out 6 metres 1000 metres to winning post, 3 metres remainder. Sectional 608 metres

**RACE 1: FRED WORTHLEY MEMORIAL HANDICAP - 1400 metres**

**GOING GAGA** (S. Cahill) - inclined to lay in under pressure in the straight.

**KIRONA** (L. German) - jumped away awkwardly. Held up from the entrance to the straight until inside the 200 metres.

**ROSELLI STING** (D. Tourneur) - difficulty obtaining clear ground from the entrance of the straight until in the vicinity of the 200 metres. Rider reminded of his obligations in riding his mounts out to the end of the race in accordance with AR131(b).

**MAI SHINY CHOICE** (T. Pannell) - laid out under pressure in the straight.

**COOL MAVERICK** (G. Lo) - a post-race veterinary examination revealed no visible abnormalities.

**RACE 2: SAROA NO RACING WITHOUT OWNERS OAKLANDS PLATE -1400 metres**

**ISCARIOT** (T. Pannell) - in the vicinity of the 300 metres was inconvenienced when tightened onto JACK'S A CRACKER by POUTING LIPS, which laid in. Rider explained that the gelding had not stretched out throughout the event and weakened of its own accord from the vicinity of the 400 metres. A post-race veterinary examination revealed no visible abnormalities.

**JACK'S A CRACKER** (D. Tourneur) - inclined to lay out under pressure in the straight.

**POUTING LIPS** (J. Holder) - jumped away awkwardly. Raced greenly from the vicinity of the 600 metres and in the vicinity of the 300 metres laid in inconveniencing ZOULAH and ISCARIOT. Laid in for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

**RACE 2: SAROA NO RACING WITHOUT OWNERS OAKLANDS PLATE -1400 metres (Cont'd)**

**ZOULAH** (R. Clark) - at the entrance to the straight had to be steadied momentarily when POUTING LIPS laid in.

**RACE 3: GRAND SYNDICATES PROUD TO SUPPORT SA RACING HANDICAP - 1250 metres**

**COUNTER DRIVE** (R. Clark) - taken out slightly at the entrance to the straight onto ENOUGH SWAGGER by YULONG JUNE. A post-race veterinary examination revealed no visible abnormalities.

**DR DEE DEE** (L. German) - stood flat-footed and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

**YULONG JUNE** (B. Vorster) - momentarily held up in the vicinity of the 400 metres and in obtaining clear ground at the entrance to the straight, brushed with COUNTER DRIVE, which was taken out slightly.

**YANKEE LOU** (D. Tourneur) -rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded.

**ENOUGH SWAGGER** (E. Boyd) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Momentarily inconvenienced at the entrance to the straight when COUNTER DRIVE was taken out.

**RACE 4: ON THE PULSE EQUINE HANDICAP - 1550 metres**

**NUDGE BAR (NZ)** (D. Tourneur) - shifted in on jumping away onto TERRITORY TITAN.

**TERRITORY TITAN** (R. Clark) - jumped away awkwardly and shortly after lost its position when hampered by NUDGE BAR (NZ), which shifted in. Raced fiercely in the early and middle stages of the event.

**LORD GILBERT** (J. Holder) - jumped away awkwardly. In the vicinity of the 300 metres became awkward in its action and was eased from the event. A post-race veterinary examination revealed that the gelding had fractured it's off fore carpal bone and was humanely euthanased.

**MANNIX** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**FIGHTING DRAGON** (D. Thornton) - jumped away awkwardly.

**RACE 5: DUCTAIR HANDICAP - 1550 metres**

**STREET SHEIK** (W. Egan) - slow to begin.

**FLYING KRUPT** (D. Thornton) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

**FRANCE'S BOY** (S. Fawke) - inclined to lay in under pressure in the straight.

**TRISTANO** (L. German) - jumped away awkwardly. Raced keenly in the early and middle stages of the event. Following the event rider was examined by the First Care Medical Personnel and passed fit ride.

**DIAMONDS ARE** (J. Potter) - had difficulty in obtaining clear ground from the entrance to the straight until the vicinity of the 200 metres.

### **RACE 6: WILLOW GROVE STUD HANDICAP - 1000 metres**

The start of this event was delayed approximately three minutes.

**CASHED** (L. German) - had difficulty obtaining clear ground at the entrance to the straight until the vicinity of the 100 metres when obliged to alter course to the inside of SEVEN YEAR REWARD, which laid out.

**FILL THE FLUTE** (D. Thornton) - reared on exiting the mounting yard and stuck a perimeter fence. A late scratching at 3.12 pm by order of Stewards on veterinary advice.

**BOLD STAR** (R. Clark) - Stewards questioned the rider in relation to the celebratory gesture she made prior to passing the winning post. After considering her explanation and taking into account that she had never been spoken to regarding a similar breach in the past, she was reprimanded under AR131(c).

**SEVEN YEAR REWARD** (J. Holder) - laid out over the concluding 150 metres and near the 100 metres rolled out inconveniencing CASHED, which was obliged to alter course.

**READY SUNSHINE** (K. Lau) - rider dropped his whip approaching the finish.

**OGUNDE** (G. Lo) - raced keenly in the early and middle stages of the event.

### **RACE 7: PUNT CLUB HANDICAP - 2400 metres**

**SUPER SWOOP** (R. Clark) - rider reported in her opinion the gelding felt sore. A post-race veterinary examination revealed no visible abnormalities.

**DISCO REBEL** (D. Tourneur) - raced keenly in the early and middle stages of the event.

**LOOKING AROUND (NZ)** (C. Puls) - jumped away awkwardly. Raced wide without cover throughout the event.

### **RACE 8: RACING.COM HANDICAP - 1250 metres**

**MR HAMILTON** (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

**PALE ALE** (E. Boyd) - contacted on jumping away.

**MARINA** (S. Fawke) - jumped away awkwardly and shifted in contacting PALE ALE and then back out contacting MISSCINO. Approaching the 1000 metres was inconvenienced when tightened onto TRUPT by MISSCINO.

**PRETIOSA** (K. Lau) - jumped away awkwardly. A post-race veterinary examination revealed the gelding had bled from both nostrils. Trainer, Mr K. Sweeney, was advised that as this was PRETIOSA's second bi-lateral bleed it was now ineligible to start in a race in accordance with AR79(6).

**TRUPT** (L. German) - permission was granted for the rider to only claim 1.5kg of his allowance. Inconvenienced approaching the 1000 metres when contacted by MARINA.

**MISSCINO** (J. Holder) - contacted on jumping away. Approaching the 1000 metres shifted in onto MARINA, which was inconvenienced when tightened onto TRUPT. Rider reminded of his obligations when shifting ground.
