RACE 1: COOPERS HANDICAP - 1506 metres

ROSELLI STING (K. Crowther) - slow to begin.

BIG CALL (C. Lions) - raced keenly in the early and middle stages of the event.

RACE 2: CORNERSTONE STUD HANDICAP - 1200 metres

LITTLE RICH BOY (S. Fawke) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

MAGIC PHANTOM (T. Voorham) - slow to begin. Laid in under pressure in the straight.

FORTUNE FOLLOWS (J. Holder) - inclined to lay in, in the straight.

PICARGO (D. Tourneur) - a post-race veterinary examination revealed the gelding was showing signs of colic. First aid administered.

RACE 3: TERRACE FUNCTION CENTRE / SABOIS MAIDEN PLATE - 1506 metres

DONE GOOD (T. Voorham) - slow to begin. Momentarily held up inside the 300 metres. Laid in under pressure in the straight.

OLIVE GROVE (J. Chau) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

TICKET TO TEXAS (K. Bishop) - raced wide without cover throughout the event.

THE IRON LADY (J. Holder) - a post-race veterinary examination revealed the mare was showing signs of thumps. First aid administered.

KRUPTONITE (S. Fawke) - jumped away awkwardly. Lost its off hind plate during the event.

RACE 4: TAB HANDICAP - 1100 metres

OLIVER'S TALE (K. Lau) - inconvenienced in the vicinity of the 900 metres when **QUIVERS** shifted in. Shortly after, had to be steadied when tightened onto **QUIVERS** by **TRIPLE DEEZ**, which had been taken out.

TRIPLE DEEZ (D. Tootell) - in the vicinity of the 800 metres was taken out onto **OLIVER'S TALE** by **DEVONTE**. Laid in under pressure in the straight.

DEVONTE (J. Chau) - raced keenly in the early and middle stages of the event and in the vicinity of the 800 metres rolled out onto **TRIPLE DEEZ**.

EMINENT SON (B. Vorster) - raced wide without cover throughout the event.

IN THE FAST LANE (T. Voorham) - shifted in and away from **SONIC DEED** over the concluding stages.

JACKPOT JOHNNY (K. Crowther) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

SONIC DEED (D. Tourneur) - laid in over the concluding stages.

QUIVERS (B. Vale) - shifted in, in the vicinity of the 900 metres onto **OLIVER'S TALE**. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: PROPER CLEAN HANDICAP - 1200 metres

GOUGERS (B. Vorster) - raced keenly in the early stages of the event when racing in restricted room between other runners.

PERFECT COMMAND (K. Crowther) - inclined to lay in under pressure in the straight.

SEE ME ROLLIN' (J. Potter) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

LIPPSY SHUFFLE (L. Neindorf) - laid in under pressure in the straight.

TYCOON FLUTTER (NZ) (S. Fawke) - slow to begin.

RACE 6: HOLDFAST INSURANCE HANDICAP - 2112 metres

OURKHANI (P. Gatt) - rider pleaded guilty to a charge under AR132(7)(a)(ii) for using his whip on more than five occasions prior to the 100 metres and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

SPIEGEL GROVE (J. Holder) - jumped away awkwardly.

COFFEE AMOUR (T. Voorham) - raced wide without cover throughout the event.

BARBIE'S BOY (S. Logan) - slow into stride. Lost its near fore plate during the event.

HAPPY ATOM (D. Tourneur) - slow to begin.

TURNPIKE (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

KARAOKE EXPRESS (K. Bishop) - raced fiercely in the early and middle stages of the event.

RACE 7: G&J CIVIL HANDICAP - 1706 metres

PICKELHAUBE (T. Voorham) - inclined to lay out under pressure in the straight.

LIGHT THE WAVES (B. Vorster) - brushed by EXALTED DEE in the vicinity of the 100 metres.

YANKEE EYES (A. Jordsjo) - a post-race veterinary examination revealed no visible abnormalities.

SPLASH SOME CASH (S. Logan) - raced keenly in the early and middle stages of the event. Hung out rounding the home turn. Laid in under pressure in the straight.

EXALTED DEE (J. Holder) - rolled out in the vicinity of the 100 metres and brushed LIGHT THE WAVES.

DIAMONDS ARE (J. Chau) - slow to begin.

RACE 8: KINGSFORD HOTEL HANDICAP - 1200 metres

EXALTED LAURETTA (R. Hurdle) - laid out under pressure in the straight and brushed ALASKAN JADE on a number of occasions.

ALASKAN JADE (J. Chau) - brushed on a number of occasions in the straight by EXALTED LAURETTA.

COMMANDING DIVA (J. Potter) - hampered and lost its position on jumping away when tightened onto GALCRUM by JAAMINT.

JAAMINT (P. Gatt) - jumped away awkwardly and shifted in contacting COMMANDING DIVA. A post-race veterinary examination revealed no visible abnormalities.

RUSTYDUSTYSUNSHINE (S. Logan) - raced keenly in the early and middle stages of the event.

AMBIBELLA (D. Tourneur) - a post-race veterinary examination revealed no visible abnormalities.

MAGNUS MAGIC (S. Fawke) - raced keenly in the early and middle stages of the event.

RACE 9: AUSBIA ELECTRICAL HANDICAP - 1100 metres

BELLOMO (J. Holder) - rider reported the gelding may have jarred up during the event. A post-race veterinary examination revealed no visible abnormalities.

DAMASCUS MOMENT (R. Hurdle) -raced wide without cover throughout the event.

PANDEIA (S. Logan) - raced keenly in the early and middle stages of the event.

KNOTTED (S. Fawke) - jumped away awkwardly. Stewards questioned S. Fawke in relation to his riding of this gelding during the event with particular reference from the 400 metres to the 150 metres. After considering his explanation, he was advised that Stewards felt that his ride bordered on being considered a breach of AR129(2), in that he should ride with reasonable and permissible measures throughout the race to ensure the rider's horse is given full opportunity to win or obtain the best possible place in the field. Rider was advised in future to ensure his mounts were fully tested and ride in a manner that does not invite questions from the Stewards. A post-race veterinary examination revealed the gelding to be lame in the near foreleg. Trainer, Ms K. McKerlie, was advised that a Veterinary Certificate of Fitness was required prior to a future trial or race start. First aid administered.
