RACE 1: CROSER HANDICAP (TO BE RUN ON THE PARKS TRACK) - 1000 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

SGHIRRIPA (C. Rawiller) - near the 600m shifted in and bumped BRISTLER. Laid in under pressure in the straight.

WHO'S CLANG (S. Tomlinson) - laid in under pressure in the straight.

ZUFASTA (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

ROCKSTAR MEGGSY (J. Holder) - jumped away awkwardly.

STORYTELLER (B. Price) - jumped away awkwardly.

BRISTLER (C. Newitt) – near the 600m was momentarily inconvenienced and became unbalanced when contacted by SGHIRRIPA. Rider reported that the gelding raced greenly throughout the event.



HISWAY (O. Ridge) - a post-race veterinary examination revealed no visible abnormalities.

RACE 1: CROSER HANDICAP (TO BE RUN ON THE PARKS TRACK) - 1000 Metres (cont'd)

SHOOTING FOR STARS (A. Livesey) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight.

RUNAWAY BELLE (K. Crowther) – inside the 100m improved onto the heels of BRISTLER and was obliged to alter course to obtain clear ground.

EMMOOKI MAGIC (J. Potter) - raced wide without cover throughout the event.

RACE 2: TAB SOUTH AUSTRALIAN SIRES' PRODUCE STAKES (TO BE RUN ON THE PARKS TRACK) - 1400 Metres

AIR ASSAULT (J. Holder) - laid out under pressure in the straight.

NODACHI (J. Allen) - shifted out and away from AIR ASSAULT over the concluding 100m of the event.

LONG LOST FRIEND (D. Bates) - laid in under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

DIAMONDS CHOICE (C. Jones) - had a haematoma which burst on its off side hind quarters. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race. Trainer, Mr C. Bieg was questioned in relation to the haematoma on the gelding's hind quarters. After considering his explanation he was reminded of his obligations under AR105(1) to advise Stewards of any matter and/or treatment which may affect the horse's performance prior to acceptance time. Jumped away awkwardly. Laid out under pressure in the straight.

TOKYO STAR (NZ) (C. Parnham) - slow to begin.

Correct weight was delayed to allow rider, J.Allen (NODACHI), placed second, to view the vision in the straight.

RACE 3: FOTOBASE GROUP AUTUMN SERIES FINAL (TO BE RUN ON THE PARKS TRACK) - 1400 Metres

JAGUARY (NZ) (T. Pannell) - hampered on jumping away when tightened onto DAWNBURST by STARTS WITH HELLO.

TEXAN WINDSTORM (J. Allen) – shifted in on jumping away onto CLASSY BANNER. Held up from the entrance to the straight until near the 200m and then had difficulty obtaining clear ground until inside the 100m. A post-race veterinary examination revealed no visible abnormalities.

CLASSY BANNER (C. Newitt) - shortly after the start lost its position when tightened onto TURFITT by TEXAN WINDSTORM, which shifted in. Raced keenly in the early and middle stages of the event. Near the 300m was inconvenienced when taken out onto TURFITT by GARRIRE.

STARTS WITH HELLO (J. Toeroek) - Stewards permitted J. Toeroek to ride the gelding 0.5kg over its declared weight of 54.0kg. Jumped away awkwardly and shifted out onto JAGUARY (NZ). Shortly after the start was hampered when LEON'S SHOUT shifted out. Raced fiercely in the middle stages of the event. Had difficulty obtaining clear ground from the entrance to the straight until inside the 300m.

DAWNBURST (D. Moor) - on jumping away was inconvenienced when its hind quarters were contacted by JAGUARY (NZ), which had been taken out.

TURFITT (D. Tourneur) - near the 300m had to be momentarily steadied when CLASSY BANNER was taken out into its running line.



LEON'S SHOUT (A. Livesey) - shifted out shortly after the start onto STARTS WITH HELLO.

GARRIRE (C. Jones) - Stewards permitted C. Jones to ride the gelding 0.5kg over its declared weight of 54.0kg. Near the 300m shifted out onto CLASSY BANNER, which was inconvenienced when taken out on TURFITT, which had to be momentarily steadied. Rider was reminded of her obligations under AR131(a).

RACE 4: SAROA REMEMBERS CHRIS KAY HANDICAP - 1200 Metres

SYNCLINE (S. Tomlinson) – near the 900m reduced the speed of his mount resulting in EXTRA MILE improving onto its heels and having to shift out abruptly. Stewards determined that although the rider reduced the pace it was not excessive as required under AR131(d); however, S. Tomlinson was reminded of his obligations in relation to slowing the speed of his horse. Near the 200m shifted out and contacted RUSHAWAY LAD, which was taken out onto the hind quarters of MANHATTEN TIMES.

MANHATTEN TIMES (J. Holder) – near the 200m was inconvenienced and turned in when its hind quarters were contacted by RUSHAWAY LAD. Commenced to shift in inside the 200m across the running line of RUSHAWAY LAD and SYNCLINE. Near the 100m shifted in onto AIGUILETTE, which was forced to race in restricted room for a short distance. Rider was severely reprimanded under AR131(a) and advised, in future, to stop riding and straighten his mounts earlier than he did on this occasion.

MAGNETIC EDGE (S. Payne) – near the 900m was inconvenienced when taken wider by RUSHAWAY LAD, which had been taken out. Near the 50m was accidentally struck in the vicinity of the head by the whip of D. Moor (RUSHAWAY LAD).

EXTRA MILE (J. Toeroek) – commenced to race fiercely near the 900m, t improved onto the heels of SYNCLINE as the pace eased and then shifted out abruptly and contacted RUSHAWAY LAD, which was hampered and taken out into the running line of MAGNETIC EDGE. Held up from the entrance to the straight and was not fully tested to the line.

AIGUILETTE (C. Newitt) – near the 100m was forced to race in restricted room for a short distance when MANHATTEN TIMES shifted in.

RUSHAWAY LAD (D. Moor) - near the 900m was hampered and taken out into the running line of MAGNETIC EDGE when contacted by EXTRA MILE, which improved onto the heels of SYNCLINE and shifted out abruptly. Near the 200m was inconvenienced when tightened onto MANHATTEN TIMES by SYNCLINE.

Correct weight was delayed to allow rider, C. Newitt (AIGUILETTE) placed second and that gelding's Trainer, Mr J. Macmillan to view the official vision of the straight. After doing so, C. Newitt (AIGUILETTE) lodged a protest against J. Holder (MANHATTEN TIMES) being declared the winner, alleging interference in the vicinity of the 100m. After considering the evidence, acting on their own observations and viewing the official vision, Stewards dismissed the objection.

RACE 5: DAVID 'DT' THOMAS MEMORIAL PROVINCIAL SUPER SERIES FINAL - 1800 Metres

DOMINUS (NZ) (J. Toeroek) - raced keenly in the early and middle stages of the event.

PRINCE JOFRA (K. Crowther) - laid in under pressure in the straight.

WOLFBURN (S. Tomlinson) - raced keenly in the early and middle stages of the event.

PORT ROYAL (J. Allen) - raced wide without cover throughout the event.

CAPTAIN BRITAIN (IRE) (D. Oliver) - lost its near hind plate during the event. Laid in under pressure in the straight.

PEACEMAKER (T. Voorham) - raced keenly in the early and middle stages of the event.

GETOUTTHEWAY (S. Logan) - lost its position shortly after the start when FLIGHT DECK (NZ) was taken out across its running line.

I NEED A DRINK (A. Livesey) – shifted out shortly after the start onto SHINSEKI. Raced keenly in the early and middle stages of the event.



MISS KERMIE (C. Jones) - Stewards permitted C. Jones to ride the mare 0.5kg over its declared weight of 54.0kg. Lost its off hind plate en route to the barriers and required Farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to race.

RACE 5: DAVID 'DT' THOMAS MEMORIAL PROVINCIAL SUPER SERIES FINAL - 1800 Metres (cont'd)

STADIUM OF LIGHT (NZ) (J. Eaton) - lost its near hind plate during the event. Raced keenly in the early and middle stages of the event.

SHINSEKI (B. Price) – taken out shortly after the start onto UNDERSTATEMENT. A post-race veterinary examination revealed no visible abnormalities.

UNDERSTATEMENT (D. Moor) - taken out shortly after the start into the running line of GETOUTTHEWAY. Shortly after was bumped by SHINSEKI.

FLIGHT DECK (NZ) (C. Newitt) - jumped away awkwardly.

RACE 6: SKYCITY SA SPRINT SERIES FINAL - 1100 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

STAR HILLS (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

KEEP READING (J. Toeroek) – Co-trainers, Mr R. Jolly and Ms C. Jolly advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt settle further back with cover in the event if possible. Horse settled behind midfield.

PRAIRIE FIRE (D. Oliver) – inside the 100m was inconvenienced by CLASSY KENNY, which shifted out.

HONGBAO (D. Moor) – slow to begin. Forced to race in restricted room for a number of strides near the 200m between PRAIRIE FIRE and MR HAVE A CHAT, which both shifted ground slightly.

SHIRSHOV (K. Crowther) - raced wide without cover throughout the event. Laid in under pressure in the straight.

QEYAADY (J. Eaton) – raced wide without cover throughout the event. Hung out rounding the home turn and under pressure in the straight. A post-race veterinary examination revealed a slow post-race recovery.

SILVER ON RED (C. Parnham) - raced keenly in the early and middle stages of the event.

BUBBLE OVER (E. Finnegan) - a post-race veterinary examination revealed no visible abnormalities.

MR HAVE A CHAT (S. Logan) - a post-race veterinary examination revealed no visible abnormalities.

TRYGVE (J. Holder) - slow to begin.

CLASSY KENNY (C. Newitt) - jumped away awkwardly. Rounding the home turn was awkwardly placed on the heels of HONGBAO. Inside the 100m shifted out and inconvenienced PRAIRIE FIRE.

HELLO LADIES (B. Price) – inconvenienced on jumping away when tightened onto SHIRSHOV by JIMMYS EDGE.

THE TRANCE FACTOR (C. Jones) - Stewards permitted C. Jones to ride the mare 0.5kg over its declared weight of 54.0kg.

JIMMYS EDGE (T. Voorham) – shifted out on jumping away onto HELLO LADIES.

RACE 7: THOMAS FARMS SOUTH AUSTRALIAN DERBY - 2500 Metres

SUIZURO (O. Bosson) - a post-race veterinary examination revealed no visible abnormalities.

DUNKEL (NZ) (W. Egan) - laid in under pressure in the straight.

RACE 7: THOMAS FARMS SOUTH AUSTRALIAN DERBY - 2500 Metres (cont'd)

HIGH APPROACH (J. Allen) - raced keenly in the middle stages of the event.

RED SUN SENSATION (B. Higgins) - held up from approaching the 400m until near the 300m. Inside the 400m was accidentally struck on the head by the whip of D. Tourneur (PRINCE TIKEA).

LOCO (D. Oliver) - laid in under pressure in the straight.

GOTTABESAVVY (NZ) (T. Pannell) – a post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-trainers, Mr T. Busuttin and Ms N. Young were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

PROMISES KEPT (M. Zahra) - inclined to shift about under pressure in the straight.

AIN'T HE GRAND (B. Allen) - raced keenly in the early and middle stages of the event. Near the 400m was forced to race in restricted room for a short distance between the heels of DUNKEL (NZ) and SUIZURO, which both shifted ground slightly. Rider explained the colt raced fresh in today's event due to the month gap between runs and blinkers being re-applied. He added AIN'T HE GRAND pulled hard throughout the event, commenced to weaken from the 500m and shifted about under pressure. A post-race veterinary examination revealed no visible abnormalities.

DUNWOODY (NZ) (J. Fry) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

CAPTAIN PLUTO (NZ) (D. Moor) - jumped away awkwardly.

NORTHERN BARRAGE (J. Holder) - held up from approaching the 400m until near the 300m.

RESERVOIR DOG (J. Toeroek) – slow to begin. Raced keenly in the early and middle stages of the event. Held up from approaching the 400m until near the 200m. Rider reported that gelding felt short in its action on pulling up. A post-race veterinary examination revealed no visible abnormalities.

SHE'S FIT (C. Parnham) - raced wide without cover throughout the event.

RACE 8: ADELAIDE GALVANISING INDUSTRIES ADELAIDE GUINEAS - 1600 Metres

PEARL ADIOS (O. Bosson) - rider explained that the gelding never travelled and when placed under pressure did not respond to his riding. A post-race veterinary examination revealed no visible abnormalities.

STAR VEGA (IRE) (M. Zahra) - inconvenienced on jumping away when tightened between BALLON D'OR and TENACE.

PARTY AT ARTIE'S (W. Egan) - shifted out on jumping away onto PAMPUNI.

WINE BARRON (NZ) (D. Oliver) - jumped away awkwardly and shifted in onto PAMPUNI.

RABTAT (J. Eaton) - jumped away awkwardly.

MERCHANT BOSS (C. Jones) - Trainer, Mr T. Doudle advised Stewards prior to the event of a change of tactics in that he would instruct his rider to attempt to take up a forward position in the event if possible. Horse led.

TENACE (B. Allen) – jumped away awkwardly, shifted in and contacted STAR VEGA (IRE). Hung in throughout the event and made contact with the running rail on a number of occasions between the 1000m and the 800m. Rider reported that the gelding was not suited by the blinkers, hung in throughout the event and proved difficult to ride out in the straight.



PARTY PRINCESS (J. Holder) - laid in under pressure in the straight.

PAMPUNI (K. Crowther) – hampered and lost its position on jumping away when tightened between PARTY AT ARTIE'S and WINE BARRON (NZ).

RACE 8: ADELAIDE GALVANISING INDUSTRIES ADELAIDE GUINEAS - 1600 Metres (cont'd)

FLORAL OASIS (B. Price) - rider explained that he was instructed to take up the lead in this event and after jumping away well, the filly improved to sit outside of MERCHANT BOSS of its own accord. He added that inside the 1200m he had attempted to restrain to take a position behind that gelding; however, FLORAL OASIS continued to fight him, resulting in both runners extending their lead on the field. A post-race veterinary examination revealed no visible abnormalities.

BALLON D'OR (T. Pannell) - jumped away awkwardly, shifted out and contacted STAR VEGA (IRE).

RACE 9: GRAND SYNDICATES HANDICAP - 1050 Metres

HALLOWED GROUND (S. Logan) - jumped away awkwardly. Raced in restricted room for a short distance near the 200m. Rider explained that the gelding travelled well in the early and middle stages; however, when placed under pressure in the straight failed to let down as she had anticipated and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

LIBERTY BLUE (S. Tomlinson) - laid out under pressure in the straight. Near the 200m shifted out onto LADY SIMONE.

MAGIC PHANTOM (A. Livesey) - raced keenly in the early and middle stages of the event.

DEMON BLOOD (M. Zahra) - inclined to shift about under pressure in the straight.

LADY SIMONE (B. Price) - near the 200m was inconvenienced when tightened between LIBERTY BLUE and RANGER FRANK, which both shifted ground.

RANGER FRANK (S. Payne) - laid in under pressure in the straight. Near the 200m shifted in and contacted LADY SIMONE.

THE GOV (T.Pannell) - laid out under pressure in the straight.

EFFORTKAT (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

MY RUBY (J. Toeroek) - raced keenly in the early and middle stages of the event.
