RACE 1: MAYURA STATION MAIDEN HANDICAP - 1200 Metres

ZEYDANA (C. Jones) - near the 100m rider dropped her whip.

BONANSKI (J. Maund) - Stewards permitted J. Maund to ride the gelding 0.5kg over its declared weight of 54.0kg.

FLOYD'S PREDICTION (NZ) (K. Walters) - jumped away awkwardly. Held up for clear running from the 500m until near the 400m.

MIZZ BEEBEEFF (Z. Lloyd) - held up for clear running from near the 600m until inside the 400m, and shortly after bumped with COTE DES BAR, which rolled out.

COTE DES BAR (D. Tourneur) – jumped away awkwardly. Raced wide without cover throughout the event. Inside the 400m rolled out and bumped MIZZ BEEBEEFF. A post-race veterinary examination revealed no visible abnormalities.

AJNA CHAKRA (D. Caboche) - Stewards permitted D. Caboche to ride the mare 0.5kg over its declared weight of 54.0kg. Jumped away awkwardly. Raced greenly throughout the event.



#### RACE 2: WATTLE RANGE COUNCIL MAIDEN PLATE - 1550 Metres

FREE FALLIN' (K. Crowther) - jumped away awkwardly. Raced wide without cover throughout the event.

JOHNNY CIGAR (S. Fawke) - slow into stride.

LOCH GORMAN (J. Maund) - hung in throughout the event.

SANDHILL REBEL (D. Caboche) - raced wide without cover in the early stages.

THE PSYCHOLOGIST (NZ) (J. Opperman) – a post-race veterinary examination revealed no visible abnormalities.

DANTASIA (A. Livesey) - kicked by another runner behind the barriers. Underwent a pre-race veterinary examination and was deemed suitable to start. Slow to begin.

# RACE 3: GOLDACRES & SEBASTOPOL MACHINERY BENCHMARK 68 HANDICAP - 1400 Metres

CHILL WITH TEEJAY (T. Voorham) - held up for clear running from the 500m until inside the 400m.

WINGS OF PASTRAMI (B. Wong) - a post-race veterinary examination revealed no visible abnormalities.

THANASI (J. Opperman) - jumped away awkwardly.

BOMBER'S KISS (A. Livesey) - jumped away awkwardly.

MELISSA KATE (NZ) (K. Walters) - jumped away awkwardly.

## RACE 4: DIGIORGIO FAMILY WINES BENCHMARK 58 HANDICAP - 900 Metres

The start of this event was delayed approximately two minutes owing to a delay with an interstate race.

NOT ENOUGH EFFORT (S. Payne) - Stewards accepted an explanation from trainer, Mr H. Dwyer, as to why the gelding was presented to race with bar plates in this event.

COMRADE BILL (K. Crowther) – approaching the finish shifted in onto GYPSY CROWN, which was inconvenienced. Rider was reminded of her obligations under AR131(a) and advised to take greater care in future.

JUKEBOX LUCY (NZ) (J. Opperman) - jumped away awkwardly and was slow to begin.

GYPSY CROWN (T. Voorham) - approaching the finish was inconvenienced as COMRADE BILL shifted in.

TOP UP (K. Walters) - a post-race veterinary examination revealed the gelding to have atrial fibrillation. Co-trainers, Messrs B. & K. Post, were advised that the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

BRASH STUDENT (B. Wong) - underwent a pre-race veterinary examination on arrival on course as it had not raced since December 2019 and was deemed suitable to start. Kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination and deemed suitable start. Jumped away awkwardly.

GIALLO (H. Yuen) - rider dropped her whip approaching the 100m.

ARACHNATTACK (A. Livesey) - hung out throughout the event.

#### RACE 5: G SQUARE RATING 0 - 58 HANDICAP - 1550 Metres

The start of this event was delayed approximately two minutes.

ANEWDAYDAWNING (K. Crowther) - on arrival at the barriers underwent a pre-race veterinary examination and was found to be lame in the off foreleg (2/5) and therefore deemed unsuitable to start. Acting on this advice Stewards declared ANEWDAYDAWNING a late scratching at 3.02pm. Trainer, Mr M. Townsend, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

LOOKING SUAVE (NZ) (K. Walters) - on jumping away was inconvenienced when taken in by DUKE OF ANJOU.

AMFISSA (NZ) (J. Eaton) - jumped away awkwardly, shifted out and bumped COSTA MARGO. Hung out throughout the event.

SHINY ROCK (S. Fawke) - raced keenly in the early and middle stages of the event.

COSTA MARGO (Z. Lloyd) - on jumping away bumped AMFISSA (NZ), which shifted out.

DRONE STRIKE (A. Livesey) - over-raced throughout the event. Rider reported that her saddle slipped forward near the 600m placing her at a disadvantage for the remainder of the event. A post-race veterinary examination revealed no visible abnormalities.

DUKE OF ANJOU (T. Voorham) - jumped away awkwardly and shifted in onto LOOKING SUAVE (NZ).

# RACE 6: SQUIB GROUP RATING 0 - 54 HANDICAP - 1400 Metres

The start of this event was delayed approximately one minute owing to the late arrival of the horses at the barriers.

QUATTRO PORTE (S. Fawke) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.

ANOTHER WHINE (J. Maund) - underwent a pre-race veterinary examination on arrival on course as it had not raced since March 2022 and was deemed suitable to start. A post-race veterinary examination revealed no visible abnormalities.

TRANSFERENCE (B. Wong) - shortly after the start was restrained and shifted in, in an attempt to gain cover.

LAST ZERPRISE (Z. Lloyd) - raced wide without cover throughout the event.

# RACE 7: JOHN CHAY & CO MILLICENT CUP - 2050 Metres

PRINCE JOFRA (S. Fawke) – from its wide barrier shortly after the start was restrained and shifted in to obtain cover. Laid in under pressure in the straight. When questioned in relation to the tactics adopted in this event, rider explained that from the wide barrier it was his opinion that his best option was to restrain his mount shortly after the start and take up a position towards the rear of the field. He added that he felt the track was suited to horses coming from off the speed and running on late. He further stated that in hindsight, given the pace of the race, he should have allowed his mount to find a position closer to the speed. A post-race veterinary examination revealed no visible abnormalities.

HASTA LA FIORENTE (S. Payne) - raced keenly in the early and middle stages of the event.

BEAR ARMS (T. Voorham) - rider reported that the mare was disappointing in today's event. She added that it was her intention to settle closer; however, she was unable to do so. She added that BEAR ARMS came off the bridle from near the 600m and was very disappointing to the finish.

UNDERSTATEMENT (J. Maund) - Stewards permitted the J. Maund to ride the gelding 0.5kg over its declared weight of 54.0kg.

# RACE 7: JOHN CHAY & CO MILLICENT CUP - 2050 Metres (cont'd)

BASSONS (A. Livesey) – underwent a pre-race veterinary examination on arrival on course and was deemed suitable to start. Raced keenly throughout the event. Near the 1600m, when being restrained, got its head up and lost ground. A post-race veterinary examination revealed no visible abnormalities.

## RACE 8: BOWMAN & BOWMAN BENCHMARK 58 HANDICAP - 1200 Metres

MCCAIN (J. Eaton) - acting on advice from trainer, Mr M. Hickmott, that the gelding had been fractious in the horse transport to the course and would be unsuitable to race Stewards declared MCCAIN a late scratching at 8.55am. Mr Hickmott was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

FULL OF DASH (NZ) (D. Caboche) - shortly after the start contacted with FINE THINGS.

MOORAK MISS (A. Livesey) - slow to begin.

FINE THINGS (B. Wong) - shortly after the start had its hindquarters turned when contacted by FULL OF DASH (NZ).

INNOCENT PEGG (Z. Lloyd) - held up for a short distance rounding the turn near the 200m.
