RACE 1: ELDERS MAIDEN PLATE - 1400 Metres

KID KINGDOM (D. Gillett) - slow to begin.

MOOSE RIVER (S. Fawke) - laid in, in the straight.

RACE 2: THE HAWKER HOTEL MAIDEN PLATE - 1100 Metres

SCHUELLER (C. Tootell) – became fractious in its barrier shortly after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race. Reared on jumping away and lost considerable ground. Trainer, Mr D. Penna was advised that the gelding must perform to the Stewards' satisfaction in an Official Barrier Trial prior to a future race. A post-race veterinary examination revealed no visible abnormalities.


RACE 3: SMULDERS CONTRACTING BENCHMARK 58 HANDICAP - 1100 Metres

LORD VARYS (H. Yuen) - rider became unbalanced momentarily approaching the finish.

RUSTYDUSTYSUNSHINE (M. Henderson) – laid in, in the straight.

VIETTI (C. Tootell) - slow to begin.

PRINCESS SALLY (R. Pearson) – on arrival on course rider, R. Pearson made an application to Stewards to ride PRINCESS SALLY 1.0kg above its original declared weight. Stewards permitted R. Pearson to ride the mare 1.0kg over its declared weight of 55.0kg. R. Pearson pleaded guilty to a charge of under 190(3) and was fined \$100.



RACE 4: NORTHPOINT TOYOTA HAWKER CUP (BENCHMARK 70 HANDICAP) - 1750 Metres

GRINZINGER STAR (NZ) - a post-race veterinary examination revealed no visible abnormalities.

PAULO PACE (C. Tootell) - near the 1600m when laying in, shifted in onto CATALINA BLUE.

LETTEMGO (R. Pearson) – on arrival on course rider, R. Pearson made an application to Stewards to ride LETTEMGO 1.0kg above its original declared weight. Stewards permitted R. Pearson to ride the gelding 1.0kg over its declared weight of 55.0kg. R. Pearson pleaded guilty to a charge of under 190(3) and was fined \$100.

OBELOS (GB) (S. Fawke) - on jumping away was inconvenienced when the inside barrier partition bounced back and appeared to strike the gelding.

CATALINA BLUE (B. Wong) - near the 1600m was taken in by PAULO PACE, which shifted in.

FIABLE (D. Gillett) - a post-race veterinary examination revealed no visible abnormalities.

PIERRE BIZEL (M. Henderson) – on arrival on course rider, M. Henderson made an application to Stewards to ride PIERRE BIZEL 1.0kg above its original declared weight. Stewards permitted M. Henderson to ride the gelding 1.0kg over its declared weight of 55.0kg. M. Henderson pleaded guilty to a charge of under 190(3) and was fined \$100.

JAMCRA (NZ) (R. Milnes) - jumped away awkwardly. Near the 1600m had to be steadied when the gelding improved onto the heels of CATALINA BLUE, which had been taken in by PAULO PACE, which shifted in. Shortly after appeared to clip the heels of CATALINA BLUE, dipped and as a result lost ground.

RACE 5: HAWKER EARTHMOVERS RATING 0-52 HANDICAP - 1400 Metres

REGAL ROCKET (R. Pearson) - held up momentarily rounding the home turn.

TONY'S REWARD (C. Tootell) - a post-race veterinary examination revealed no visible abnormalities.

VEGAS DESTINY (NZ) (J. Doyle) - slow to begin.

BAY OF ANGELS (B. Wong) - jumped away awkwardly.

HIGHLY RIGHTEOUS (Z. Lloyd) - laid in, in the straight.
