Report on Race Meeting held at Murray Bridge Racecourse by the Murray Bridge Jockey Club on Saturday, 27 May 2023

RACE 1: MOSEL SURVEYORS MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately three minutes.

GETABLE (T. Pannell) - slow to begin. Rider reported that the colt did not travel throughout the event and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

HOT OFF (S. Payne) - jumped away awkwardly.

NEVER SURRENDER (C. Jones) - jumped away awkwardly. A post-race veterinary examination revealed no visible abnormalities.

PROVEN CORRECT (T. Voorham) - lost its off fore plate en route to the barriers and required farrier attention. Underwent a pre-race veterinary examination and was deemed suitable to race. Inconvenienced on jumping away when tightened onto WALK LIKE AN ANGEL by SANTASTICO. Lost both fore plates during the event.

REGAL DANCER (J. Toeroek) - jumped away awkwardly. Rider reported that the gelding raced greenly throughout the event.

SANTASTICO (D. Caboche) - shifted out abruptly on jumping away onto PROVEN CORRECT.

RACE 1: MOSEL SURVEYORS MAIDEN PLATE - 1000 Metres (cont'd)

THE STALKER (D. Tourneur) - jumped away awkwardly and shortly after was inconvenienced by REGAL DANCER, which shifted out.

VINTAGE STAR (S. Tomlinson) - laid out under pressure in the straight.

INTACTO (L. Neindorf) – a post-race veterinary examination revealed the filly to be lame in the near hind leg (2/5). Co-trainers, Mr G. Richards and Mr D. Moyle were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

WALK LIKE AN ANGEL (J. Holder) - laid out under pressure in the straight. Rider reported that the filly raced greenly throughout the event.

RACE 2: GROWTH IQ MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately four minutes.

OH SHOW (R. Hurdle) - held up from the entrance to the straight until near the 300m.

VEZERE RIVER (T. Voorham) - slow to begin. Laid in under pressure in the straight.

AMBELLO (E. Finnegan) - required its tongue tie to be re-fitted after being loaded in its barrier.

DELCREDERE (S. Payne) - slow to begin. Near the 700m laid out and became awkwardly placed on the heels of TIPPERARY TESS for a short distance. Held up from near the 500m until approaching the 100m. Near the 100m shifted in and away from IMITATOR onto TIPPERARY TESS.

IRISH THORN (NZ) (C. Murray) – near the 700m raced in restricted room for a number of strides between the heels of MAGNADAL and IMITATOR.

MISS STEIGLITZ (T. Pannell) - kicked by another runner en route to the barriers. Underwent a prerace veterinary examination which revealed a laceration to its off hind leg and was deemed unsuitable to race. First aid administered. Trainer, Mr M. Webb was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

FANCIFY (NZ) (B. Price) - reared in its barrier stall after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race.

SPURIER (K. Crowther) - inclined to lay in under pressure in the straight.

TIPPERARY TESS (J. Maund) - had to be steadied near the 100m when DELCREDERE shifted in.

MAGNADAL (D. Caboche) - raced keenly in the early and middle stages of the event.

RACE 3: PLC STRAIGHT UP HANDICAP - 2500 Metres

The start of this event was delayed approximately one minute to avoid a clash with an interstate event.

VERIMLI (FR) (B. Price) - rider reported that the gelding travelled well in the early and middle stages of the event; however, near the 1200m was off the bit. He added that near the 600m when placed under pressure VERIMLI (FR) failed to respond to his riding and was disappointing. A post-race veterinary examination revealed no visible abnormalities.

CORAGGIO (K. Walters) - raced keenly in the middle stages of the event.

MASTER OF ZERPRISE (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

CALL ME VEXATIOUS (C. Murray) - Stewards permitted C. Murray to ride the gelding 0.5kg over its declared weight of 54.0kg.

DANRENA (S. Logan) - laid out under pressure in the straight.



ROAD TO BLUE SKY (NZ) (D. Caboche) - jumped away awkwardly.

IRONICAL (D. Tourneur) - slow to begin.

RACE 4: CHAPMAN HEAVY MECHANICAL HANDICAP - 1800 Metres

RITRATTO (S. Tomlinson) – raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by S. Tomlinson and noted that he used it once over the final 100m of the event.

EAGLELOU (J. Potter) - had difficulty obtaining clear ground from the entrance to the straight until inside the 300m.

SANTELMO FUEGO (J. Holder) - laid in under pressure in the straight.

MOTELL (L. Neindorf) - raced keenly in the early and middle stages of the event.

PEACEMAKER (J. Toeroek) - slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

VICTORY BANDIT (D. Caboche) - inconvenienced on jumping away. Raced keenly in the early and middle stages of the event.

AL RANCHERO (A. Jordsjo) - jumped away awkwardly and shifted in onto VICTORY BANDIT. Laid in under pressure in the straight.

RACE 5: SMEDLEY TYRE SERVICE HANDICAP - 1200 Metres

HOPE AT HAND (J. Holder) – inconvenienced on jumping away when its hind quarters were contacted and turned by NOBLE MAGNATE, which had been taken out. Laid in under pressure in the straight. Rider reported that in his opinion the filly is better suited on a firmer track.

KLABEL (NZ) (J. Toeroek) - shifted out abruptly on jumping away onto THE GREAT BABY.

DUNMAGHLAS (L. Neindorf) – rider reported that the gelding travelled well in the early and middles stages; however, when placed under pressure at the entrance to the straight commenced to give ground and he had become concerned with its action near the 300m. A post-race veterinary examination revealed no visible abnormalities.

BIRDIES GALORE (A. Livesey) - rider reported that in her opinion the filly was reluctant racing between other runners. A post-race veterinary examination revealed a slow post-race recovery.

MAGICAL SLIPPER (K. Crowther) - had difficulty obtaining clear ground from approaching the 200m until near the 100m. A post-race veterinary examination revealed no visible abnormalities.

COLD CASE (S. Tomlinson) - near the 700m shifted in and away from CHARLESFORT and contacted the hind quarters of NOBLE MAGNATE. Had difficulty obtaining clear ground from the 500m until near the 300m.

THE GREAT BABY (J. Potter) - lost its position on jumping away when tightened onto NOBLE MAGNATE by KLABEL (NZ).

NOBLE MAGNATE (C. Murray) - hampered on jumping away when tightened onto HOPE AT HAND by THE GREAT BABY. Near the 700m rider became extremely unbalanced in the saddle when the gelding's hind quarters were contacted and turned in by COLD CASE. Laid in under pressure in the straight.

CHARLESFORT (T. Voorham) - near the 700m shifted in slightly onto COLD CASE. Laid in under pressure in the straight. Rider reported that the gelding was inclined to lay in throughout the event.

RACE 6: PRIME IRRIGATION HANDICAP - 1200 Metres

DESIGNER CHEF (T. Pannell) - raced wide without cover throughout the event.

PICARGO (A. Livesey) - laid in under pressure in the straight.

MAGNETIC EDGE (S. Payne) - jumped away awkwardly.

MASTERATI (C. Murray) - Stewards received a request from Trainer, Mr N. Irwin that the gelding be withdrawn due to the track downgrade. Stewards acceded to this request and declared MASTERATI a late scratching at 12:30pm.

ARKHAM KNIGHT (E. Finnegan) - raced keenly in the early and middle stages whilst being restrained.

EXTRA MILE (S. Tomlinson) - raced keenly in the early and middle stages of the event. Had difficulty obtaining clear ground from approaching the 300m until near the 200m when it was able to ease to the outside of other runners to obtain clear racing room.

HEARTY LASS (D. Caboche) - raced fiercely in the early and middle stages of the event.

RACE 7: DAISH IRRIGATION & FODDER HANDICAP - 1200 Metres

The start of this event was delayed approximately four minutes.

LOPE DE WOLF (S. Payne) - became fractious in its barrier after being loaded, broke through the structure and galloped riderless prior to being captured. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Stewards declared LOPE DE WOLF a late scratching at 3.09pm. Co-trainer, Mr G. Kent was advised that the gelding would now be required to be tractable in the barriers in an Official Barrier Trial or Approval to Race jump-out prior to accepting for a future race.

KENYAN WONDER (C. Rawiller) - rider was unable to claim down to his minimum riding weight of 59.5kg. As there was no other claiming apprentice available he was granted permission to ride at 60.0kg; however, was fined \$200 under AR143(14)(a) for failing to claim his full allowance.

MR MARATHON MAN (GB) (B. Price) - raced wide without cover throughout the event. Rider became concerned with the gelding's action near the 300m. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Trainer, Mr D. Saxon was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

IMPORTANT PRODUCT (J. Potter) - fractious in its barrier after being loaded. Trainer, Ms S. Murphy was advised that a warning had been placed on the gelding in relation to its barrier manners. Slow to begin.

COMMODITY (K. Crowther) - a post-race veterinary examination revealed no visible abnormalities.

COMMANDER MEROO (A. Livesey) - raced keenly in the early and middle stages of the event.

REAL ROY (A. Jordsjo) - struck a perimeter fence en route to the barriers. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race.

RACE 8: AFFORDABLE TREE SOLUTIONS HANDICAP - 1000 Metres

The start of this event was delayed approximately three minutes.

THE BIG EASY (B. Price) - fractious in its barrier after being loaded. Underwent a pre-race veterinary examination and was deemed suitable to race. Co-trainers, Mr W. Clarken and Mr N. O'Shea were advised that a warning had been placed on the gelding in relation to its barrier manners. A post-race veterinary examination revealed no visible abnormalities.

MOON AND BACK (C. Jones) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

RACE 8: AFFORDABLE TREE SOLUTIONS HANDICAP - 1000 Metres (cont'd)

CLASSY KENNY (S. Payne) - rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was suspended from riding in races for a period to commence at midnight on Saturday, 3 June 2023 and to conclude at midnight on Wednesday, 7 June 2023: a period of two meetings. In determining penalty Stewards had regard for the totality of the use of the whip by S. Payne and noted that he used it on eight occasions over the final 100m of the event.

MANAGE THE CYCLE (J. Holder) - raced in restricted room for a number of strides near the 300m.

ZUFASTA (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

RACE 9: B&L COX ELECTRICAL HANDICAP - 1400 Metres

The start of this event was delayed approximately 3 minutes.

WATER INTO WINE (S. Tomlinson) - a post-race veterinary examination revealed no visible abnormalities.

FOOTLIGHTS (NZ) (J. Opperman) - shifted out on jumping away onto HEADPHONES. Had to momentarily steady near the 400m when HEADPHONES shifted out.

PLATINUM WOLF (L. Neindorf) - jumped away awkwardly.

LOMAX (C. Murray) - slow to begin. Had difficulty obtaining clear ground from the entrance to the straight until inside the 200m

SIX FOOT SONG (J. Toeroek) - hampered on jumping away and lost its position when tightened onto HYPERCANE by HEADPHONES.

SCENIC HOST (J. Holder) - held up from near the 500m until inside the 200m when it shifted in to obtain clear ground, onto HEADPHONES, which had to be steadied. Rider was reminded of his obligations when shifting ground.

DAWNBURST (S. Payne) - laid out under pressure in the straight.

SIYATA (GB) (T. Pannell) - jumped away awkwardly.

HEADPHONES (D. Tourneur) - taken out on jumping away onto SIX FOOT SONG. Shifted out slightly near the 400m into the running line of FOOTLIGHTS (NZ). Rider was reminded of his obligations when shifting ground. Had to momentarily steady inside the 200m when SCENIC HOST shifted in.
