Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Bordertown Racecourse by the Bordertown Racing Club on Sunday, 4 June 2023

RACE 1: BORDERTOWN STONE SUPPLIES BENCHMARK 64 HANDICAP - 1550 Metres

SHINY ROCK (S. Fawke) - raced keenly in the early and middle stages of the event. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that he used his whip on more than five occasions prior to the 100m and was fined \$200. In determining penalty Stewards had regard for the totality of the use of the whip by S. Fawke and noted that he used it on four occasions over the final 100m of the event. Rider also pleaded guilty to a charge under AR132(7)(a)(i) in that he used his whip in consecutive strides prior to the 100 metres and was reprimanded.

NASEEB (T. Voorham) – rider explained that the gelding travelled well until placed under pressure from inside the 600m, failed to respond to her riding and was disappointing to the finish. A post-race veterinary examination revealed the gelding to have atrial fibrillation. Trainer, Ms. S. Murphy was advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

IMPULSE DIAVOLO (Z. Lloyd) - raced wide throughout the event.

RACE 2: WOOLSHED INN BENCHMARK 68 HANDICAP - 2000 Metres

HASTA LA FIORENTE (D. Tourneur) - held up from the 400m until the entrance to the straight.

LORD OF DARKNESS (NZ) (Z. Lloyd) - laid in under pressure in the straight.

RACE 3: BORDERTOWN PUMPS & REFRIGERATION BENCHMARK 68 HANDICAP - 1100 Metres

ROHLON DRUNK (B. Wong) - laid in under pressure in the straight.

FRANCE'S BOY (J. Opperman) - stumbled on jumping away.

MYSTICANO (S. Fawke) - a post-race veterinary examination revealed no visible abnormalities.

COMRADE BILL (K. Crowther) - raced keenly in the early and middle stages of the event.



RACE 3: BORDERTOWN PUMPS & REFRIGERATION BENCHMARK 68 HANDICAP - 1100 Metres (cont'd)

PRANCE 'N' DANCE (H. Yuen) - raced wide without cover throughout the event. A post-race veterinary examination revealed no visible abnormalities.

IN THE SUN (J. Doyle) - laid out in the straight.

RACE 4: CREASER CONSTRUCTIONS MAIDEN PLATE - 1300 Metres

The start of this event was delayed approximately one minute owing to a repair to a running rail

ANNIHILATE (T. Voorham) - laid in, in the straight. In the vicinity of the 150m shifted in across the running of MIZZ BEEBEEFF. Rider was severely reprimanded under AR131(a) and advised, in future, to make a greater effort to straight her mounts when they are laying in. Contacted ZION'S GATE on a couple of occasions approaching the finish.

HASTA LA TRUCE (C. Puls) - slow to begin. Raced greenly throughout the event.

ZION'S GATE (D. Tourneur) - approaching the finish made contact with ANNIHILATE on a couple of occasions.

MAI TIME (A. Jordsjo) - raced wide without cover throughout the event.

MIZZ BEEBEEFF (J. Potter) - in the vicinity of the 150m was obliged to take hold when tightened between ZION'S GATE and ANNIHILATE, which shifted in.

SO SAY SUNNY (S. Fawke) - laid out in the straight.

Correct weight was delayed to allow D. Tourneur (ZION'S GATE), placed second, to view the vision in the straight.

RACE 5: BRANDT RATING 0-54 HANDICAP - 1550 Metres

INNOCENT PEGG (Z. Lloyd) - raced wide without cover throughout the event.

RIPPA EAGLE (NZ) (J. Eaton) - laid out in the straight.

MOXATATION (D. Tourneur) - slow to begin. Laid out in the straight.

REDWINELOVER (C. Murray) - slow to begin.

RACE 6: HARPERS PARCEL FREIGHT RATING 0-54 HANDICAP - 1100 Metres

ALL BEANS (S. Fawke) - in the vicinity of the 900m shifted in and took SCOTTISH SOLDIER in and tightened the running of GIALLO. Rider was found guilty of a charge of careless riding under AR131(a) and was suspended from riding in races for a period to commence midnight Monday, 12 June 2023 and to conclude midnight Wednesday, 21 June 2023, a period of four meetings. In determining penalty, Stewards took into account S. Fawke's good record. Laid in, in the straight.

KLATTEN (D. Caboche) - near the 900m had to be checked and lost its position when tightened for room between LIVIN' LOOSE (NZ) and STAKE A CLAIM, which shifted in. Rider explained that after being tightened for room in the vicinity of the 900m the mare did not stretch out fully. He added that from the vicinity of the 600m commenced to give ground, made abnormal respiratory sounds and for that reason he did not ride KLATTEN out in his usual manner. A post-race veterinary examination revealed no visible abnormalities.

SCOTTISH SOLDIER (A. Jordsjo) - in the vicinity of the 900m was taken in by ALL BEANS and tightened the running of GIALLO.

STAKE A CLAIM (Z. Lloyd) - near the 900m shifted in and tightened the running of KLATTEN. Rider was reprimanded under AR131(a) and advised, in future, to make a great effort to straighten her mounts when they commence to shift ground. Laid in, in the straight.

RACE 6: HARPERS PARCEL FREIGHT RATING 0-54 HANDICAP - 1100 Metres (cont'd)

GIALLO (J. Eaton) - jumped away awkwardly and as a result was slow to begin. In the vicinity of the 900m had to be checked and lost its position when tightened by SCOTTISH SOLDIER, which was taken in. Laid out in the straight.

RACE 7: O'CONNORS CASE IH BENCHMARK 58 HANDICAP - 1300 Metres

JACKTHEGIANTSLAYER (H. Ingram) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

UNLIMITED ABILITY (K. Walters) - laid out in the straight.

MCCAIN (J. Eaton) – stood flat footed as the start was effected and as a result was slow to begin (approximately three lengths).

CANIDAE (J. Opperman) - jumped away awkwardly.

NANA DULCE (C. Murray) - late scratching at 8:40am by order of Stewards.

LOVE FROM LUCY (Z. Lloyd) - underwent a pre-race veterinary examination on arrival on course as it had not raced in over 12 months and was deemed was deemed suitable to race.
