RACE 1: PORT PIRIE BUS SERVICE MAIDEN PLATE - 1498 Metres

The start of this event was delayed approximately two minutes.

KID KINGDOM (D. Gillett) - slow to begin.

SOLIS ORTUS (S. Fawke) - jumped away awkwardly and shifted in onto GOLDEN AKEED.

TOMMY TOMATO (H. Yuen) – held up for a short distance rounding the home turn behind TUFF OPERATOR.

TUFF OPERATOR (R. Hurdle) - laid in, in the straight.

GOLDEN AKEED (C. Murray) - lost its position on jumping away when tightened onto COME AGAIN by SOLIS ORTUS, which shifted in.

ROYAL LANDING (D. Caboche) - jumped away awkwardly.

RACE 2: SCA MAIDEN PLATE - 1200 Metres

The start of this event was delayed approximately two minutes.

RACE 2: SCA MAIDEN PLATE - 1200 Metres (cont'd)

AUGUSTA POWER (A. Livesey) – shifted out on jumping away onto FAMOUS KNIGHT. A post-race veterinary examination revealed no visible abnormalities.

JUSTEDEE (R. Hurdle) – near the 1100m shifted in onto CLASSY LILLY, which was momentarily steadied. Rider was reminded of his obligations under AR131(a).

SCRIBNER CREEK (R. Milnes) – approaching the 200m shifted in onto BARBADSON. Rider was reminded of her obligations under AR131(a).

FAMOUS KNIGHT (H. Yuen) - taken out on jumping away onto IMITATOR by AUGUSTA POWER, which shifted out.

IMITATOR (D. Caboche) - taken out on jumping away onto CLASSY LILLY by FAMOUS KNIGHT. A post-race veterinary examination revealed no visible abnormalities.

CLASSY LILLY (D. Gillett) - jumped away awkwardly and shifted out onto GO FORMAL, shortly after was inconvenienced when IMITATOR shifted out. Raced keenly in the early stages of the event. Near the 1100m was momentarily steadied when the filly improved onto the heels of JUSTEDEE, which shifted in. From near the 600m hung out and proved difficult to ride for the remainder of the event.

GO FORMAL (C. Tootell) - hampered on jumping away when tightened onto PURPLE VALLEY by CLASSY LILLY, which shifted out and lost its position.

PURPLE VALLEY (S. Fawke) - approaching the 200m was taken wider onto BARBADSON by CLASSY LILLY, which was hanging out.

BARBADSON (A. Jordsjo) - jumped away awkwardly and as a result was slow to begin. Approaching the 200m was hampered when taken out slightly by PURPLE VALLEY onto the heels of SCRIBER CREEK.

RACE 3: AUGUSTA AUTOMALL BENCHMARK 64 HANDICAP - 1600 Metres

GRINZINGER ALLEE (NZ) (D. Gillett) - shifted out on jumping away and bumped LEONARDA.

LEONARDA (R. Hurdle) - on jumping away bumped with GRINZINGER ALLEE (NZ), which shifted out. A post-race veterinary examination revealed no visible abnormalities.

GRINZINGER BISHOP (NZ) (J. Potter) – near the 1000m raced in restricted room to the inside of GRINZINGER ALLEE (NZ) for a short distance.

I'M KENNY (H. Yuen) - jumped away awkwardly. Raced keenly in the early and middle stages of the event.

JAMCRA (NZ) (R. Milnes) - laid out under pressure in the straight.

SIRMAZE (D. Caboche) - raced keenly in the early and middle stages of the event.

RACE 4: IAN (PORKY) FARR MEMORIAL BENCHMARK 58 HANDICAP - 1498 Metres

The start of this event was delayed approximately five minutes.

SHINY ROCK (S. Fawke) - jumped away awkwardly.

VELARO (M. Henderson) – refused to load. Stewards declared VELARO a late scratching at 2.58pm. Trainer, Mr M. Wayman was advised that the gelding would now be required to load without delay in an Official Barrier Trial or Approval to Race jump-out prior to accepting for a future race.



MARINA (R. Pearson) - near the 1100m had to be steadied when tightened by MOOSE RIVER, which shifted in.

CHONCAPE (H. Yuen) - jumped away awkwardly. Laid out in the straight.

RACE 4: IAN (PORKY) FARR MEMORIAL BENCHMARK 58 HANDICAP - 1498 Metres (cont'd)

MOOSE RIVER (D. Gillett) - near the 1100m shifted in onto MARINA. Rider was severely reprimanded under AR131(a) and advised, in future, to make a greater effort to ensure she is sufficiently clear when shifting ground.

Onward (B. Wong) - underwent a pre-race veterinary examination on arrival on course and was deemed suitable to race. Had its tongue tie re-applied on arrival at the barriers. A post-race veterinary examination revealed no visible abnormalities.

OUR JOURNEYMAN (R. Milnes) – near the 800m lost use of her off side iron and raced with a significant disadvantage for the remainder of the event.

RACE 5: TRAVELLERS REST HOTEL RATING 0 - 58 HANDICAP - 1200 Metres

SUPER SHARP (H. Yuen) - shifted out on jumping away onto GULINGI.

GULINGI (C. Murray) - tightened on jumping away when SUPER SHARP shifted out and FUNOFTHEFAIR shifted in. Appeared to clip the heels of SUPER SHARP, knuckled and lost ground.

SO SILENT (A. Jordsjo) - laid out in the straight.

FUNOFTHEFAIR (J. Doyle) - shifted in on jumping away onto GULINGI. Laid out in the straight.

POUVOIR DE SOIE (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

TOUGH LASSIE (D. Caboche) - a post-race veterinary examination revealed no visible abnormalities.

RACE 6: OFFICE NATIONAL RATING 0 - 52 HANDICAP - 1100 Metres

NOT A SINGLE BID (C. Murray) - a post-race veterinary examination revealed no visible abnormalities.

TALLU (R. Milnes) - bumped on jumping away with HEY MICHAEL, which shifted in. Rider reported that the gelding changed lead legs on several occasions and raced greenly throughout the event.

THE REGULAR SHOW (A. Jordsjo) - laid out in the straight.

CASE CLOSED (D. Gillett) - laid out rounding the home turn and in the straight.

HEY MICHAEL (S. Fawke) – shifted in on jumping away and bumped TALLU. When questioned in relation to the gelding's improved performance, Trainer, Mrs K. Mckerlie explained that the gelding did not have much luck in its previous runs and performed as expected in today's event.

UNICORNY (S. Tomlinson) – Trainer, Mr R. Atkinson made a submission to Stewards to scratch UNICORNY as he was of the opinion that the available non-claiming rider was unsuitable to replace, rider S. Tomlinson, who was indisposed. Stewards acceded to Mr. Atkinson's request and declared UNICORNY a late scratching at 11.17am.

RACE 7: JB RADIATORS & WINDSCREEN SERVICE CLASS TWO HANDICAP - 1396 Metres

The start of this event was delayed approximately one minute.

SIR TOOP (H. Yuen) - when questioned in relation to leading in today's event, rider explained that the gelding began well and started to over race so she elected to allow the gelding stride to the lead of its own accord.



RACE 7: JB RADIATORS & WINDSCREEN SERVICE CLASS TWO HANDICAP -1396 Metres (cont'd)

JOURNEY IN TIME (S. Fawke) – rider explained that the mare travelled well in the early and middle stages; however, when asked for an effort did not respond to his riding. He added that he is of the opinion that JOURNEY IN TIME may have not handled the quick back up in runs. A post-race veterinary examination revealed no visible abnormalities.

SPRINGSUN (D. Gillett) - slow to begin.

CATALINA BLUE (A. Livesey) – raced keenly in the early and middle stages of the event. Near the 1300m was inconvenienced when SPACE FORCE rolled out slightly.
