RACE 1: ADELAIDE GALVANISING INDUSTRIES HANDICAP - 1000 Metres

KALASEC (S. Tomlinson) – raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. Approximately 100m after the winning post fell for no apparent reason and dislodged its rider. S. Tomlinson was examined by First Care Medical personnel and was transported to hospital for further assessment and observations. An inquiry into this incident was adjourned to a date and time to be fixed to allow S. Tomlinson to be present. A post-race veterinary examination revealed no visible abnormalities. Co-trainers, Mr R. Jolly and Ms. C Jolly were advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race.



NINEVEH (T. Pannell) - when questioned in relation to the filly's performance, rider could offer no explanation. A post-race veterinary examination revealed that the filly had been galloped on its near hind leg above the hock. Trainer, Mr P. Payne was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.



VOLTAGE POINT (T. Voorham) - raced keenly in the early and middle stages of the event.

WALK LIKE AN ANGEL (J. Holder) - raced greenly in the straight.

SOLE SILENCE (A. Livesey) - laid out under pressure in the straight. A post-race veterinary examination revealed no visible abnormalities.

RACE 2: THOMAS FARMS HANDICAP - 1250 Metres

The start of this event was delayed approximately 15 minutes owing to the ambulance transfer following the incident in Race 1.

PICARGO (A. Livesey) - laid in under pressure in the straight.

EXTRA MILE (B. Price) - laid in under pressure in the straight.

LEGLESS LADY (J. Holder) – had difficulty obtaining clear ground from the entrance to the straight until approaching the 200m. Rider explained that the mare travelled well in the early and middle stages; however, when asked to quicken did not let down as he had expected. He added that he suggested to the trainers that LEGLESS LADY may benefit from the addition of blinkers. A post-race veterinary examination revealed no visible abnormalities.

MR MARATHON MAN (GB) (B. Price) - fractious in its float en route to course. Underwent a prerace veterinary examination on arrival on course which revealed a laceration to its lower jaw and was deemed unsuitable to race. First aid administered. Acting on this advice MR MARATHON MAN (GB) was declared a late scratching by order of Stewards at 10.25am. Trainer, Mr D. Saxon was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

RACE 3: SKYCITY HANDICAP - 1300 Metres

The start of this event was delayed approximately three minutes owing to JOY MCCOY (NZ) having to be re-saddled on arrival at the barriers.

JOY MCCOY (NZ) (B. Price) - required to be re-saddled on arrival at the barriers.

COLD CASE (J. Toeroek) - hampered on jumping away.

LUCKY BLUE (J. Potter) – raced wide without cover throughout the event. Laid out under pressure in the straight. When questioned in relation to the gelding's performance, rider explained that it was disappointing when placed under pressure. A post-race veterinary examination revealed the gelding to have cardiac arrhythmia. Trainer, Mr. D. Halliday was advised the results of an ECG are to be forwarded to the Racing SA Veterinary Surgeon and a Veterinary Clearance would be required prior to the gelding performing satisfactorily in an Official Barrier Trial.

OFCOURSE I WILL (J. Opperman) - slow to begin. Rider reported that the gelding raced greenly and he was of the understanding it was the stable's intention to give it a spell. A post-race veterinary examination revealed no visible abnormalities.

THE GREAT BABY (T. Voorham) - raced wide without cover throughout the event.

MAGICLANE (A. Livesey) - following the declaration of acceptances Trainer, Mr R. Balfour made a gear application to remove earmuffs from the mare's race gear. Stewards acceded to this request and acting under AR206(2) fined Mr Balfour \$200. Shifted out on jumping away onto COLD CASE.

RACE 4: THE FOTOBASE GROUP HANDICAP - 1400 Metres

TERRITORY TITAN (A. Jordsjo) - rider reported that the gelding did not muster speed early, raced keenly in the middle stages, pulled itself forward from near the 1000m and raced wide without cover for the remainder of the event.

RACE 4: THE FOTOBASE GROUP HANDICAP - 1400 Metres (cont'd)

WILD IMAGINATION (NZ) (J. Toeroek) - lost its off fore plate during the event. Laid out under pressure in the straight.

RACE 5: ETER ELBERG FUNERALS HANDICAP - 1250 Metres

KLABEL (NZ) (A. Livesey) - raced keenly in the early and middle stages of the event.

POMPEII EMPIRE (C. Murray) - laid out under pressure in the straight.

NOBLE MAGNATE (J. Toeroek) - shifted out at the entrance to the straight onto SEVEN SECRETS, which had to be eased and as a result lost ground resulting in BALLON D'OR, which was attempting to improve having to be steadied. Rider was severely reprimanded under AR131(a) and advised, in future, to take greater care when shifting ground. Laid out under pressure in the straight.

SEVEN SECRETS (J. Holder) - jumped away awkwardly. At the entrance to the straight was inconvenienced and had to be eased when NOBLE MAGNATE shifted out. A post-race veterinary examination revealed no visible abnormalities.

BALLON D'OR (B. Price) – at the entrance to the straight was laying in and became awkwardly placed on the heels of SEVEN SECRETS and then was forced to take hold when that gelding lost ground after being eased.

MERCHANT BOSS (J. Opperman) - rider was reminded of his obligations under AR131(b) in relation to riding his mounts out fully to the finish.

RACE 6: FLEURIEU MILK COMPANY HANDICAP - 1400 Metres

RUN AND TELL (A. Livesey) - raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

SIYATA (GB) (T. Pannell) - raced fiercely in the early and middle stages of the event. Inclined to lay in under pressure in the straight.

DAYAN STAR (J. Holder) - when questioned in relation to the gelding's performance, rider reported that it travelled well in the early and middle stages; however, did not respond to his riding and in his opinion, may not have been suited to today's track conditions. A post-race veterinary examination revealed no visible abnormalities.

IMPOSING SUSPECT (NZ) (L. Neindorf) - slow to begin.

TURFITT (D. Tourneur) - had difficulty obtaining clear ground from near the 400m until inside the 300m.

CANYONERO (B. Price) – rider reported that the gelding did not feel comfortable in its action over the concluding 100m and on pulling up. A post-race veterinary examination revealed no visible abnormalities.

MOORAK MISS (T. Voorham) - slow to begin.

MOSS THE BOSS (S. Logan) - raced wide without cover throughout the event.

RACE 7: GRAND SYNDICATES SUPPORTING SAROA HANDICAP - 2250 Metres

The start of this event was delayed approximately two minutes to avoid a clash with an interstate event.

GOLDEN CRUSADER (FR) (J. Toeroek) - raced fiercely in the early and middle stages of the event. Laid out under pressure in the straight.

CANFORD (T. Pannell) - laid out under pressure in the straight.

RACE 7: GRAND SYNDICATES SUPPORTING SAROA HANDICAP - 2250 Metres (cont'd)

SMILING ASSASSIN (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

RITRATTO (B. Price) - raced keenly in the early and middle stages of the event.

TOYETIC (J. Opperman) - slow to begin. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed no visible abnormalities.

WOLF PRINCE (J. Eaton) - slow to begin. Laid in under pressure in the straight.

RACE 8: GRAND SYNDICATES HANDICAP - 1550 Metres

RIALTOR (S. Logan) - laid out under pressure in the straight. Inside the 100m shifted out onto MARACOURT, which was tightened onto PLATFORM (NZ). Rider was reminded of her obligations when shifting ground.

MARACOURT (D. Tourneur) - laid out under pressure in the straight and brushed with PLATFORM (NZ) on a number of occasions.

GROUP THINK (J. Eaton) - raced wide without cover throughout the event.

RACE 9: THE JUNCTION HANDICAP - 1000 Metres

BONJOUR DE GAULLE (S. Logan) – laid out rounding the home turn and under pressure in the straight. Rider reported that the gelding never travelled and felt uncomfortable in its action rounding the home turn and in the straight. A post-race veterinary examination revealed no visible abnormalities.

JONQUEST (J. Holder) - for a short distance inside the 100m became awkwardly placed on the heels of ELSA'S PRIDE and was obliged to alter course to obtain clear ground.

ENFANT ROUGE (FR) (T. Pannell) – rider reported that the mare travelled well in the early and middle stages of the event; however, when placed under pressure in the straight failed to respond to his riding and was disappointing to the finish. He added that in his opinion the mare may not have handled the track condition. A post-race veterinary examination revealed no visible abnormalities.

BAJAN BELLE (C. Jones) – jumped away awkwardly. Raced keenly in the early and middle stages of the event. Laid out under pressure in the straight and became awkwardly placed on heels over the concluding 100m and was untested to the finish. Rider reported that she had intended to settle further forward in the event; however, after jumping away awkwardly the mare failed to muster early speed. She added that she had difficulty obtaining clear ground throughout the straight. A post-race veterinary examination revealed no visible abnormalities.

BORN TO RUN (NZ) (R. Hurdle) - Stewards acceded to a request by Trainer, Mr J. Hyam to permit the mare to race without a tongue tie. Jumped away awkwardly. Approaching the 100m improved onto the heels of TYDEUS, which was giving ground and was obliged to alter course to that gelding's inside to obtain clear ground.

VAMPIRE SLAYER (J. Opperman) - a post-race veterinary examination revealed no visible abnormalities.

THE TRANCE FACTOR (D. Tourneur) - jumped away awkwardly and was slow to begin.
