Racing SA Ltd Stipendiary Stewards' Report

Report on Race Meeting held at Ceduna Racecourse by the Ceduna Racing Club on Saturday, 2 December 2023

RACE 1: GYPSUM RESOURCES AUSTRALIA / VITERRA AUSTRALIA MAIDEN PLATE - 1200 Metres

BROOKONG (M. Henderson) - laid in, in the straight.

ROKUN (C. Tootell) – rider explained that her mount did not respond to her urgings in the early stages of the event. She added that with continued vigorous riding the gelding responded to her riding near the 400m.

THIS ONE DAD (C. Reynolds) - underwent a pre-race veterinary examination and was deemed suitable to start.

HUMEA (J. Doyle) - rider explained that in her opinion the mare did not handle the dirt track. A post-race veterinary examination revealed no visible abnormalities.

TYPAR (C. Munro) – underwent a pre-race veterinary examination and was deemed suitable to start. Laid out in the straight. Rider pleaded guilty to a charge under AR132(7)(a)(ii) in that she used her whip on more than five occasions prior to the 100m and was fined \$100. In determining penalty Stewards had regard for the totality of the use of the whip by C. Munro and noted that she used it on ten occasions over the final 100m.

RACE 2: HIGHWAY ONE MOTEL / TAB BENCHMARK 54 TROPHY RACE - 1000 Metres

RICHED (S. Fawke) - raced keenly in the early and middle stages of the event. Laid in, in the straight.

BARON OF BEDFORD (NZ) (J. Doyle) – underwent a pre-race veterinary examination and was deemed suitable to start.

ALCANNABIE (M. Henderson) - slow to begin. A post-race veterinary examination revealed no visible abnormalities.



RACE 3: CEDUNA FOODLAND CHRISTMAS BENCHMARK 58 HANDICAP - 1300 Metres

MISS LANGTRY (S. Fawke) – rider explained that the mare raced flat, did not respond to his riding when placed under pressure and was disappointing. A post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Trainer, Mr G. Lynch, was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race start.

KEEP SWINGING (J. Doyle) – dislodged its rider en route to the barrier. Underwent a pre-race veterinary examination and deemed suitable to start. J. Doyle was examined by the First Care Medical personnel and was passed fit to fulfil her remaining engagements. Trainer, Mr B. Holtham, was advised that a warning had been placed on the mare. A post-race veterinary examination revealed no visible abnormalities.

RACE 4: CURTIS'S THEVENARD CUP - 1600 Metres

AUGUSTA ROCK (C. Reynolds) - rider reported that she dropped her whip near the 500m.

VELARO (J. Doyle) – approaching the winning post was steadied when improving and awkwardly placed on the heels of GIVEPEACE A CHANCE.

SANDASTAN (S. Fawke) - rider explained that the gelding raced one-paced and in his opinion may be suited over further distances. A post-race veterinary examination revealed no visible abnormalities.

RACE 5: NUMERICAL REAL ESTATE / MCEVOY TRANSPORT BENCHMARK 54 TROPHY RACE - 1600 Metres

JAMCRA (NZ) (S. Fawke) – rider explained that the gelding would benefit from the run after being first up in its preparation. A post-race veterinary examination revealed no visible abnormalities.
