RACE 1: FILEUR COUNTRY MILE FINAL (QUALIFIED HORSES) - 1600 Metres

SEEKING GLORY (A. Livesey) - held up from near the 500m until near the 200m.

PEACEMAKER (T. Voorham) - raced keenly in the early and middle stages of the event. Laid out under pressure in the straight. Lost its near fore plate during the event. Rider reported that it was not her intention to lead; however, after jumping away well the gelding commenced to race keenly and pulled itself to the front.

POUVOIR DE SOIE (C. Murray) - Stewards permitted C. Murray to ride 0.5kg over its declared weight of 54.0kg.



#### RACE 2: TAB REBEL RAIDER SERIES FINAL (QUALIFIED HORSES) - 1200 Metres

KINETIC JEWEL (K. Crowther) - shifted in on jumping away and contacted NASHO. Shortly after the start had to be checked when tightened between WALK LIKE AN ANGEL, which shifted in and NASHO, which rolled out.

WALK LIKE AN ANGEL (J. Holder) - laid in shortly after the start onto KINETIC JEWEL. Laid in, in the early and middle stages of the event. Hung in under pressure in the straight. Lost its near hind plate during the event.

KALASEC (B. Price) - laid in under pressure in the straight.

ANOTHERHOUSE (NZ) (L. Neindorf) - raced keenly in the early and middle stages of the event. Held up from the 400m until inside the 200m.

FUN FOREVER (T. Voorham) - laid in under pressure in the straight. A post-race veterinary examination revealed the gelding to be lame in the near foreleg (3/5). Trainer, Mr A. Gluyas was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

HUGGLE TIME (A. Kelly) - a post-race veterinary examination revealed no visible abnormalities.

NASHO (J. Potter) - shifted out on jumping away and contacted KINETIC JEWEL. Shortly after rolled out onto KINETIC JEWEL.

## RACE 3: GLYNN PRETTY COUNTRY SPRINT SERIES FINAL (QUALIFIED HORSES) - 1200 Metres

CLASSY BANNER (T. Pannell) - a post-race veterinary examination revealed no visible abnormalities.

STAR JAN (T. Voorham) - en route back to the mounting yard became recumbent. Following immediate arrival of veterinary care the mare was found to have experienced an episode of cardiorespiratory failure and was deceased.

ALL BEANS (M. Collett) - raced keenly in the early and middle stages of the event.

IRISH MIST (H. Yuen) - raced wide without cover throughout the event.

SO YOU CAN (J. Toeroek) - Stewards permitted J. Toeroek to ride 0.5kg over its declared weight of 54.5kg. At the entrance to the straight was forced to race in restricted room for a number of strides between the heels of STAR JAN and STORM VOYAGER, which shifted out.

DISCO TILMORN (K. Crowther) - held up from near the 500m until inside the 300m when it was able to alter course to the inside of VERDI to obtain clear ground.

STORM VOYAGER (B. Price) - shifted out at the entrance to the straight onto SO YOU CAN. Rider was reminded of his obligations under AR131(a) when shifting ground. Laid in under pressure in the straight.

RANGER FRANK (J. Potter) - slow into stride.

#### RACE 4: TAB HAPPY TRAILS FINAL (QUALIFIED HORSES) - 1600 Metres

JACK THE LAD (J. Potter) - raced keenly in the early and middle stages of the event.

EN FRANCAIS (L. Neindorf) - raced keenly in the early and middle stages of the event.

THIRSTY GUEST (J. Toeroek) - Stewards permitted J. Toeroek to ride 0.5kg over its declared weight of 54.5kg. Laid out under pressure in the straight.

DANISH FORTUNE (T. Voorham) - laid in under pressure in the straight.

MAGNETIC EDGE (B. Price) - raced keenly in the early and middle stages of the event. Raced wide without cover throughout the event. Laid in under pressure in the straight.



#### RACE 4: TAB HAPPY TRAILS FINAL (QUALIFIED HORSES) - 1600 Metres (cont'd)

THE GUAVA (J. Opperman) - raced keenly in the early and middle stages of the event.

MASTER AT ARMS (NZ) (J. Holder) – raced keenly in the early and middle stages of the event. Laid in under pressure in the straight.

#### RACE 5: TAB SKYBEAU SERIES FINAL (QUALIFIED HORSES) - 2500 Metres

HASTA LA FIORENTE (D. Tourneur) - raced keenly in the early and middle stages of the event.

AMMO AMOR (S. Metcalfe) - laid in under pressure in the straight.

CANFORD (C. Murray) - Stewards permitted C. Murray to ride 0.5kg over its declared weight of 54.0kg.

WHATSANAMEGEORGE (K. Crowther) - near the 200m was reluctant to improve into a tight run between CANFORD and THE MAP, which rolled in and was obliged to ease to the outside of THE MAP to obtain clear ground.

MANZALA (M. Collett) - Stewards permitted apprentice, M. Collett to replace L. Neindorf on the gelding as there was no other senior rider available. Laid out under pressure in the straight. A post-race veterinary examination revealed a laceration to its off hind heel.

VINO DECASA NOSTRA (R. Milnes) – a post-race veterinary examination revealed the gelding to have cardiac arrhythmia (1st occurrence). Trainer Mr J. Lynch was advised that he was required to comply with the Racing Australia Code of Practice in order for the gelding to be reinstated to race.

SHADOW HAWK (NZ) (A. Livesey) - a post-race veterinary examination revealed no visible abnormalities.

CHARTIN (NZ) (H. Yuen) - late scratching by order of the Stewards at 12:28pm acting on confirmed advice from Co-trainer, Mr D. Moyle that the gelding was showing signs of swelling in its limbs and would be unsuitable to race. Co-trainers, Mr G. Richards and Mr D. Moyle were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

BENZ BARON (A. Kelly) - a post-race veterinary examination revealed no visible abnormalities.

## RACE 6: DAVID PEACOCK RESTRICTED SERIES FINAL (QUALIFIED HORSES) - 1800 Metres

BIT OF A REBEL (J. Toeroek) - rider reported that the gelding raced flat. A post-race veterinary examination revealed no visible abnormalities. Trainer advised that the horse will now be spelled.

HOBO BOB (J. Potter) - a post-race veterinary examination revealed no visible abnormalities.

ENTERPRISE JEWEL (M. Collett) - raced wide without cover throughout the event. Laid in under pressure in the straight. Rider pleaded guilty to a charge under AR132(6)(b) for using her whip in an action that raised her arm above shoulder height and was reprimanded. A post-race veterinary examination revealed no visible abnormalities.

A TOUCH FROSTY (C. Murray) - Stewards permitted C. Murray to ride 0.5kg over its declared weight of 54.0kg. Laid in under pressure in the straight.

PUNCHIN (K. Crowther) - laid out under pressure in the straight.

ENLIST (A. Kelly) - jumped away awkwardly.

VEE ROD (NZ) (L. Neindorf) - Stewards permitted L. Neindorf to ride 0.5 kg over its declared weight of 54.0kg. Raced keenly in the early and middle stages of the event. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-trainers, Mr G. Richards and Mr D. Moyle were advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

#### RACE 7: TAB GYTRASH SERIES FINAL (QUALIFIED HORSES) - 1200 Metres

QUEMAN (J. Potter) – contacted on jumping away. Raced keenly in the early and middle stages of the event. Rider explained that the gelding raced keenly in the early and middle stages and this was detrimental to its finishing effort. He added that in his opinion QUEMAN is better suited over a shorter distance. A post-race veterinary examination revealed no visible abnormalities.

STRUCK BY (A. Livesey) - shifted in on jumping away and contacted BELLINGER and then shifted back out and contacted QUEMAN.

OCEAN REWARD (T. Pannell) - laid out under pressure in the straight.

RIVER TWAIN (B. Price) - jumped away awkwardly and was slow to begin. A post-race veterinary examination revealed no visible abnormalities.

BELLINGER (A. Kelly) - inconvenienced when contacted on jumping away.

#### RACE 8: TAB VIDDORA SERIES FINAL (QUALIFIED HORSES) - 1200 Metres

The start of this event was delayed approximately four minutes to avoid a clash with an interstate event.

STARLITE VALLEY (S. Tomlinson) - laid out under pressure in the straight.

AZTEC DANCER (J. Opperman) - knocked its head during the loading process. Underwent a prerace veterinary examination and was deemed suitable to race. A post-race veterinary examination revealed no visible abnormalities.

MISS MUCINNI (K. Crowther) - near the 1000m shifted in and away from PICKY and then commenced to race keenly until near the 600m.

EXALTED DAME (J. Holder) - slow to begin.

SECOND TO NUN (T. Pannell) – jumped away awkwardly. Rider explained that although he had settled further back then he anticipated, the mare then travelled well in the early and middle stages; however, when asked for an effort failed to respond to his riding and was disappointing. A post-race veterinary examination revealed a slow post-race recovery.

PICKY (L. Neindorf) - shifted in on jumping away and hampered SUGGESTIVE MISS.

SUGGESTIVE MISS (A. Livesey) - inconvenienced when hampered on jumping away. Raced keenly in the middle stages when awkwardly placed on the heels of MISS MUCINNI.

ALOTAFUN (B. Price) - the cross-over nose band on the mare required an adjustment after being loaded. Jumped away awkwardly, got its head up and struck its rider in the vicinity of the head.

## RACE 9: TAB RIZIZ SERIES FINAL (QUALIFIED HORSES) - 1100 Metres

GRAND HOST (J. Opperman) - raced keenly in the early and middle stages of the event.

DELCREDERE (J. Holder) - laid in under pressure in the straight. Rider was reminded of obligations under AR131(b) in relation to riding his mounts out to the finish.

OLD TIME ROCK (S. Payne) - jumped away awkwardly. Held up from the 500m until inside the 300m.

ROSE RING (T. Voorham) - a post-race veterinary examination revealed no visible abnormalities.

ROCK HARD (A. Livesey) – reared on jumping away. A post-race veterinary examination revealed no visible abnormalities.



## RACE 9: TAB RIZIZ SERIES FINAL (QUALIFIED HORSES) - 1100 Metres (cont'd)

PROPHET'S CHOICE (D. Tourneur) - contacted a perimeter fence when leaving the mounting yard. Underwent a pre-race veterinary examination on arrival at the barriers and was deemed suitable to race. A post-race veterinary examination revealed the mare to be lame in the off foreleg (2/5). Trainer, Mr P. Chow was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.
