Report on Race Meeting held at Port Lincoln Racecourse by the Port Lincoln Racing Club on Friday, 8 December 2023

RACE 1: YUMBAH MUSSELS MAIDEN PLATE - 1000 Metres

The start of this event was delayed approximately one minute owing to the late scratching of SIR DALAPENA.

SIR DALAPENA (D. Caboche) – kicked by another runner on arrival at the barriers. Underwent a pre-race veterinary examination which revealed lacerations to its offside flank and ribs and was deemed unsuitable to race. Acting on this advice SIR DALAPENA was declared a late scratching by order of Stewards at 2.17pm. Trainer, Ms T. Kropel was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

SURVEY LANE (S. Fawke) - laid in, in the straight.

THIS ONE DAD (C. Murray) - slow to begin.

WYES TRIER (B. Wong) - near 900m appeared to dip and lost ground.

RACE 2: LINCOLN SOUTH FOOTBALL CLUB MAIDEN HANDICAP - 1350 Metres

BIG MERCH (B. Wong) – on return to the mounting yard was kicked by another runner. A postrace veterinary examination revealed the gelding to be lame in the near hind leg (4/5). Trainer, Mr S. Drewitt was advised that a Veterinary Clearance would be required prior to a future jumpout, trial or race.

RACE 2: LINCOLN SOUTH FOOTBALL CLUB MAIDEN HANDICAP - 1350 Metres (cont'd)

SHIPWRECK (C. Tootell) – raced keenly in the early and middle stages of the event. Held up for clear running from the entrance to the straight until near the 200m.

HOTFOOTIT (A. Livesey) - raced in restricted room over the concluding stages between SHIPWRECK, which rolled out and MY BOY JETT, which laid in.

I'M A MILLENNIAL (R. Milnes) – held up for clear running from the 600m until the entrance to the straight.

WADAANA (K. Crowther) – rider explained in relation to the filly's disappointing performance that it travelled only fairly in the early and middle stages and over the concluding stages it did not feel comfortable in its action and for this reason she did not ride her mount out in her normal manner. She added that, in her opinion, WADAANA would benefit from the addition of a tongue tie. A post-race veterinary examination revealed the filly to be lame in the near foreleg (3/5). First aid administered. Trainer, Mr C. Bieg was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

MIS GUIDED CHOICE (M. Collett) - near the 1200m dipped when over racing.

RACE 3: LAWRENCE & HANSON RATING 0 - 54 HANDICAP - 1000 Metres

The start of this event was delayed approximately two minutes owing to the late scratching of ROCK HARD.

JONQUEST (B. Price) - laid in under pressure in the straight.

ROCK HARD (H. Yuen) – shortly after being loaded was fractious in the barrier. Underwent a prerace veterinary examination which revealed abrasions to both hocks and was deemed unsuitable to race. Acting on this advice ROCK HARD was declared a late scratching by order of Stewards at 4.01pm.

VON GEORGE (S. Fawke) - jumped away awkwardly. Raced ungenerously throughout the event.

CEECEETEEVEE (D. Caboche) – on jumping away was inconvenienced when tightened onto HAYZEE FANTAYZEE by GET 'EM IN (NZ) and as a result lost its position. A post-race veterinary examination revealed no visible abnormalities.

DOORBEL (A. Livesey) - on jumping away bumped with GET 'EM IN (NZ), which was taken out by STRIP CLUB, which shifted out. Raced keenly in the early stages of the event.

STRIP CLUB (J. Doyle) - jumped away awkwardly and shifted out onto DOORBEL. Held up momentarily rounding the home turn behind GET 'EM IN (NZ) and shifted in to obtain clear running.

GET 'EM IN (NZ) (B. Wong) – near the 700m changed stride and became unbalanced for a short distance.

RACE 4: THE MARINA HOTEL FILLIES & MARES BENCHMARK 62 HANDICAP - 1250 Metres

EVENING BRIDE (M. Collett) - jumped away awkwardly and as a result was slow to begin.

ISA SECRET (C. Tootell) - a post-race veterinary examination revealed no visible abnormalities.

DANTELA (NZ) (H. Yuen) - jumped away awkwardly.

NASDANA (K. Crowther) – rider could offer no explanation for the mare's disappointing performance. A post-race veterinary examination revealed no visible abnormalities.

EFFORTKAT (R. Milnes) - jumped away awkwardly.

SHEMA (B. Wong) - raced greenly in the straight.



RACE 5: LEADER DISTRIBUTORS BENCHMARK 78 HANDICAP - 1000 Metres

The start of this event was delayed approximately 33 minutes until 5:53pm owing to an incident with GULINGI and rider, B. Wong. All horses were returned to the mounting yard and examined by the Club's veterinary surgeon.

AS I PLEASE (A. Livesey) - slow into stride.

ARTFUL AMBITION (S. Metcalfe) - laid out in the straight.

SANDSATION (M. Collett) – a post-race veterinary examination revealed the mare to be lame in the near foreleg (2/5). Trainer, Mr M. White was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

GULINGI (B. Wong) – on arrival at the barriers was fractious, dislodged its rider and made contact with the ground and its rider, B. Wong. Underwent a pre-race veterinary examination and was deemed unsuitable to race. Acting on this advice GULINGI was declared a late scratching by order of Stewards at 5:16pm. Trainer, Mr B. Lear was advised the gelding must perform to the Stewards' satisfaction in a trial or jump-out prior to a future race. B. Wong was examined by First Care Medical personnel and was transported to hospital for further assessment and observation. B. Wong was advised that she would require a Medical Clearance before engaging in any form of riding.

ICE HUNT (J. Doyle) - slow into stride.

RIVERSIDE ROCK (S. Fawke) - Stewards permitted S. Fawke to ride 0.5kg over its declared weight of 54.0kg. Slow to begin.

Due to the delay following the incident in this event, the race times for the remainder of the meeting were amended as follows:

RACE 6: GORDON PETERSON MEMORIAL COLTS, GELDINGS & ENTIRES BENCHMARK 62 HANDICAP - 1250 Metres

MESSERSCHMITT (S. Metcalfe) - held up for clear running from the 400m until inside the 200m.

PRESCIENT (C. Murray) - near 100m when weakening was inconvenienced when CELESTIAL ILLUSION shifted in. Rider explained that it was his intention to lead in today's event; however, the gelding did not muster enough early speed. He added that PRESCIENT does not appreciate racing amongst other runners and after being unable to obtain a position in the lead, it never travelled in today's event. A post-race veterinary examination revealed no visible abnormalities.

SIR TOOP (B. Price) – rider explained that the gelding travelled well in the early and middle stages; however, when asked for an effort did not respond to his riding and proved disappointing. A post-race veterinary examination revealed the gelding to be lame in the off hind leg (2/5). Co-trainer, Mr J. Dunn was advised that a Veterinary Clearance would be required prior to a future jump-out, trial or race.

AYLLA'S PRIDE (S. Fawke) - Stewards permitted S. Fawke to ride 0.5kg over its declared weight of 54.0kg.

JUSTAKIDD (J. Doyle) - slow into stride.

ROMMEL'S COMMAND (H. Yuen) – following the declaration of acceptances Trainer, Ms L. Faust made a gear application to add a tongue tie to the gelding's race gear. Stewards acceded to this request and acting under AR206(2) fined Ms Faust \$200. Laid in, in the straight. Held up momentarily inside the 200m and shortly after was inconvenienced when HE'S ABEL shifted in slightly.



RACE 7: ECO CLEAN BENCHMARK 76 HANDICAP - 1350 Metres

AHSO (R. Milnes) - slow to begin. Laid in, in the straight.

ROMPER STOMPER (S. Fawke) - Stewards permitted S. Fawke to ride 0.5kg over its declared weight of 54.0kg. Jumped away awkwardly. Raced keenly in the early and middle stages of the event.
